

## GLOBALSCAPE, INC. CUTEFTP PRO™ VERSION 2.0 LICENSE

**This Software is licensed, not sold. You may use this Software only as described in this license.**

**If you do not agree to the terms of this license, do not install the Software or use any registration number that was provided with the Software. You may contact the Web site or store where you purchased the license for a refund if you have not used the registration number.**

DEFINITIONS. When used in this license, these terms have the following meanings:

“Software” means the computer program known as CuteFTP Pro Version 2.0, including the Transfer Engine and Transfer Engine Software Development Kit, any updates, supplemental code or programs provided to you by GlobalSCAPE with or in connection with CuteFTP Pro, the Transfer Engine or the Transfer Engine Software Development Kit, the user's manual and Help file, any components, any related media and printed materials, and all other any related "online" or electronic documentation.

“Transfer Engine” means the portions of the Software located in the following files: ftppte.exe, gssupport.dll, sftp.dll, and ssl.dll;

### 2. GRANT OF LICENSE.

Evaluation Copy. If you acquired the license for the Software on an evaluation or trial basis, you may use the Software without charge for thirty (30) days from the day that you install the Software. You must pay the license fee and register your copy to continue to use the Software after the thirty (30) day evaluation period. To pay the license fee and register your copy, you should visit [www.globalscape.com](http://www.globalscape.com) or an authorized sales agent. For so long as the Software is the most current version of CuteFTP Pro distributed by GlobalSCAPE, you may give exact copies of the evaluation Software to anyone. You may not charge any fee for the copy or use of the evaluation Software itself, but you may charge a distribution fee that is reasonably related to any cost you incur distributing the evaluation Software (e.g. packaging). You must not represent in any way that you are selling the Software itself. Your distribution of the evaluation Software will not entitle you to any compensation from GlobalSCAPE. You must distribute a copy of this license with any copy of the Software and anyone to whom you distribute the Software is subject to this license. You may not remove any copyright, trademark or reservation of rights language displayed on, in or with the Software.

**Registered Copy.** When you purchase a license, you will be provided with a registration number. You must enable the registered license for the Software by entering the registration number as prompted by the Software. You may use the registered Software on that number of computers for which you have purchased a separate license as indicated on the invoice or sales receipt. If the Software is installed on a network server or other storage device, you must purchase a license for each separate computer on which the Software is used. The Transfer Engine remains subject to this license, but GlobalSCAPE does not claim any rights in any program or script you create to control the Transfer Engine through its Component Object Model interface. You may use a program into which you have incorporated the Transfer Engine only on those computers for which you have a license to use CuteFTP Pro, and you may not transfer or distribute such a program to any third party. If you wish to use the Transfer Engine on a computer on which you are not licensed to use CuteFTP Pro, or you wish to distribute the Transfer Engine to third parties, you must obtain a separate license for the Transfer Engine Software Development Kit. **3. RESTRICTIONS.** You may not reduce the Software to human readable form, reverse engineer, de-compile, disassemble, merge, adapt, or modify the Software, except and only to the extent that such activity is expressly permitted by applicable law notwithstanding this limitation. The Software reports this number to us either when you install the Software or enter your registration number, or both. The Software may also identify and report to us your Windows language identifier setting, IP address, and the date and time of installation and/or registration. We use this information only to count the number of installations, detect piracy, and develop rough statistical data regarding the geographic location of our users. If you register our Software, we tie this information to the personally identifiable information that we have about you.

6. TERMINATION. This license terminates if you fail to comply with its terms and conditions. If your license terminates, you must destroy all copies of the Software. The termination of this license does not limit GlobalSCAPE's other rights it may have by law.

7. INTELLECTUAL PROPERTY. You acknowledge that you have only the limited, non-exclusive right to use and copy the Software as expressly stated in this license and that GlobalSCAPE retains title to the Software and all other rights not expressly granted.
